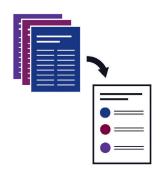
How to use this document

What is the Commonwealth Continuity of Support Programme?

The Commonwealth Continuity of Support Programme is often called CoS.

This is a programme for older people who:



are getting disability services now



won't be a part of the National Disability
 Insurance Scheme (NDIS).



The NDIS is a way of providing care and support to people with disability in Australia.



The CoS Programme will make sure that you keep getting the same support and services that you get now.



The CoS Programme will start when the NDIS reaches your area.



The Australian Government will manage the CoS Programme.



Your state or territory government used to manage these services.

What you need to know about the CoS Programme

As part of the CoS Programme:



your services will not change



 your fees will not change – if you didn't pay fees before, you won't have to now



you can stay with the same service provider
 or we can organise a new service provider
 – the person or organisation that provides
 you with supports



 if your needs change, your service provider will help you find other options



• if you had an **Individual Support Package** (ISP), you can keep this. An ISP is funding to pay for the support that you need.

Who can use the CoS Programme?

You can use the CoS Programme if you:



• are 65 years old and over



 are an Aboriginal or Torres Strait Islander person aged 50 years old and over



• can't use the NDIS



• are getting specialist disability services.

Specialist disability services are for people who need extra support to do things like:



• live in the community



live at home



• be a part of the community



• be more independent.

When can you use the CoS Programme?



When you start using the CoS Programme depends on where you live.



The NDIS is starting in different areas at different times.



This means that people will join the CoS Programme at different times.



Everyone will join the CoS Programme by 30 June 2020.



Your service provider can tell you when you will join the CoS Programme.



You can also check the **CoS website** to find out when the CoS Programme will start in your area.

What supports and services will you get?

You can keep using any specialist disability support you have been getting.

This includes:



 accommodation support – services that help you stay at home



 community support – education and support to help you be more independent



 community access – services that help you take part in your community



 respite – supports that give you and your family a short break.



If you had an ISP before, you can keep this under the CoS Programme.

There are three types of ISPs:



 service provider – where a service provider manages your money and also delivers your supports



 intermediary – where an organisation manages the money for your supports but they don't deliver your supports



 direct funding – where you manage the money for your supports. Your ISP will let you keep buying the supports in your **Service Agreement**.



A Service Agreement is a document that says you and your service provider agree about the services you are going to receive.



You should talk to your service provider to find out what services are not funded under the CoS Programme.

What happens if your needs change?



Your service provider will review your supports every 12 months.



A review is when something is looked over to see how well it has been going.



If your needs change before your review, you should talk to your service provider.

You can ask someone to support you during these reviews including a:



- family member
- friend
- carer.

Questions or concerns



Speak to your service provider if you have any questions or concerns about them.

Or you can make a complaint with the help of your:



carer
